This list contains funding eligibility **only** for Tier 3 CSFP partner municipalities. If your municipality submitted a Tier 2 a Prioritization Plan for MassDOT review by the April 1, 2021 deadline the municipality will be eligible for the full \$400,000 once it is approved.

Starting in Fiscal Year 2022, a municipality may receive a maximum of \$400,000 in Tier 3 grant funding on a rolling four-fiscal-year basis. In other words, municipalities may receive one full (\$400,000) grant or several smaller grants within any four-fiscal-year timeframe.

For example, if your municipality was awarded a total of \$200,000 in Tier 3 funds in the last three fiscal years, you may apply for up to \$200,000 in Tier 3 funds in the next (fourth) fiscal year.

It is very important to MassDOT that all eligible communities are able to receive a Tier 3 grant, and this new criteria lends towards this goal of equitable grant distribution among our partners. To learn more, visit the Tier 3 Chapter and the FAQ section of the CSFP Program Guidance document.
